Sir,


Kindly draw your attention towards the representation of Secretary, Shia Aoukaf Bachao Committee, 8/2, B.T. Road Cossipur, Kolkata – 700 002 (Near Tala Bridge) on the aforesaid subject. He has informed that the survey of the Shia Waqf is not being done as per the provisions of the Waqf Act, 1995. The Kolkata Municipal Corporation has neglected its duties and preparing a table survey report without making actual survey and ground work in respect of the Waqf properties. He has cited the following cases where actual survey has not been carried out:

Waqf Act, 1995 was amended by the Wakf (Amendment) Act, 2013 which came into force on 1st November, 2013. As per the provision of sub section 1A of section 4 survey of the Auqaf shall be completed by the State Government within a period of one year from the date of the commencement of the Wakf (Amendment) Act, 2013.

In spite of the above the complaints have been received regarding the improper survey of Shia Auqaf situated in the city of Kolkata. We request you to look into the matter and direct the Revenue Department/Survey Commissioner to take action as per law to complete the actual survey of the Auqaf.


